We will confirm whether VAT (at the current rate of 20%) is payable once you instruct us and we can calculate whether VAT is properly chargeable.)

Visas and Other Applications

Please note that our stated fee ranges below are based on :

- one application only
- an hourly rate of £200.00 (excluding VAT)
- the typical number of hours taken to complete the typical work involved, which will depend upon various factors including, but not limited to, the following :
 - the type of application
 - whether this is your first application or an extension application
 - the number of documents to consider, whether any documents need to be translated into English, and the time taken to obtain any missing or additional documents
 - whether there are any dependants to be added in your application, and their particular circumstances
 - whether there are any complex legal issues involved

Once we have had the opportunity to discuss your circumstances with you and have been able to estimate the amount of work required, we will be able to provide you with our exact fee based on the number of hours we expect to spend.

Visitor Visas

(if you want to come to the UK (usually for up to 6 months) for a holiday or vacation; or to see family or friends; or to make a short-term business trip; or to study a short-term course or do a placement or take an exam; or as an academic; or for medical reasons; or other reasons eligible under a Standard Visitor visa)

(if you plan to make regular trips of up to 6 months per visit to the UK, you can apply for a 2 year, 5year or 10 year long-term Standard Visitor visa)

(if you plan to get married or register a civil partnership within 6 months of arriving in the UK; or other reasons eligible under a Marriage Visitor visa)

(if you are invited by a UK-based organisation or client to attend an event or other permitted engagement; or if you want to do specific paid work without being sponsored under the pointsbased visa system; or other reasons eligible under a Permitted Paid Engagement visa)

a typical Work visa application can take between 6 and 12 hours to complete depending on the circumstances of your case.

Work Visas

Disbursements

(These are costs incurred during the matter that are payable to third-party providers (eg. Home Office application fees). Home Office Visa application fees vary. Indeed, some applications may not have a fee at all. You will pay this to the Home Office directly as part of the application process. There may also be additional fees payable for some types of applications depending upon your particular circumstances (eg. Biometric enrolment fee; or Life in the UK Test fee for settlement (indefinite leave to remain) applications and British citizenship applications). You can check the current Home Office and Nationality fees (see under 'Useful Links' below).

Also, as part of your visa application, you may be required to pay an 'Immigration Health Surcharge'. Whether you need to pay depends upon the immigration status you are applying for. You can check whether you need to pay and if so, how much (see under 'Useful Links' below).

| Interpreter Fees * (Varies but typically between £30.00 and £60.00 per hour) | these are difficult to estimate as it depends upon the required language, the time spent and the agency providing the interpreter. Typical TimescaleWe will normally be able to submit an application within 4 weeks of taking detailed instructions from you. However, this is
only an estimated target as it will depend upon the type of application, how soon we are provided with all of the required
information and supporting documentation (including translated documents if applicable), whether legal representations are
needed, and the complexity of any legal issues involved. We will inform you if it is likely to take longer than 4 weeks.

It is difficult to predict how long the Home Office will take to reach a decision on your application. It will depend upon the type of application and, in the case of applications made from outside the UK, where the application is submitted. For some visa applications, the Home Office do offer premium services which provide a priority or expedited service that will shorten the time for a decision to be reached.
